## **Legacy Projects**

A. WVPPCA will sponsor Legacy Projects per the following criteria:

1. Willamette Valley Oregon community forestation projects by not for profit groups on land suitable for Willamette Valley Ponderosa pine seed source.
2. Project plan will be completed by applicant that details primary group, purpose, establishment details, follow up and long term vision.
3. The request for the project will be submitted via a current dues paying member of the WVPPCA. This person cannot be an Executive Committee member or the Executive Director
4. Projects will be submitted for selection / approval by January 15 of the planting year. Projects will be formally approved by the Executive Committee. The number of projects sponsored in a single year including multi-year projects will depend on resources available.
5. Articles including pictures and signage will give appropriate recognition to WVPPCA.
6. Applicant agrees to provide a short annual report (at least one page) with pictures to WVPPCA at the end of each year WVPPCA is a cooperator.
7. Applicant is responsible for shipping and storage costs.

B. WVPPCA will participate/cooperate per the following:

1. Help with identifying technical assistance. A general guide for successful tree planting will be available.
2. Assist in obtaining up to 200 seedlings per year for no longer than a three year period. Additional seedlings maybe available for purchase at discount rates for qualifying projects.
3. Project progress will be noted in the WVPPCA annual report.
