Programming

Starting in 2025, **Mapping the Course will continue indefinitely as a 3-day event**. While each event functions as a standalone, registration can be combined into one event invoice if needed to ease your workplace administrative processing.

Workforce Development Workshop

This workshop brings together diverse forest sector stakeholders for an afternoon focused on ways to strategically advance workforce development in the region. This Workshop is linked to the new Pathways Program at Western Forestry and Conservation Association and held in conjunction with the Forest Sector Workforce Development Working Group.

The <u>Pathways Program</u> is envisioned as a 5-week field-based training of forestry specific topics. This field program is intended to fill the gap left when the large land-grant universities turned away from practical, hands-on forestry training and instead focused on general environmental teaching in classrooms. The first 5-week course is planned for summer 2025. Next year's conference will discuss this inaugural offering in more detail and outline the next year's plan. The Pathways Program will soon have a dedicated webpage with more information and schedule/registration information.

The Forest Sector Workforce Development Working Group holds monthly meetings. These monthly meetings bring together education, private industry, government, non-profits, and tribes for conversation and connection. These hybrid meeting opportunities provide space for those working in the forest sector to discuss specific topics, learn from each other, and identify ways to address workforce challenges. Forest Sector Workforce Development Working Group hybrid meetings occur on the third Wednesday of the month from 10am-12pm Pacific Time. The World Forestry Center is our new home for this annual conference. Western Forestry and Conservation Association offices are located on campus, and we are aligned in our organization missions. Although no hotel is associated with World Forestry Center, there are numerous metro/rideshare options to transport conference participants from their hotel downtown (or nearby) to the World Forestry Center campus.

All visitors who travel by car to the World Forestry Center are required to pay for parking in lots managed and monitored by the City of Portland within Washington Park, which has a pay-by-space meter system utilizing the Parking Kitty app. When planning your visit, please be aware that special events such as Zoo Concerts and other peak times can create parking shortages. The Business of Forest Products Workshop

This workshop introduces the businesses that utilize materials harvested from the forest, how raw materials are evaluated and purchased, and the associated nomenclature of the industry. Participants will gain an understanding of the values associated with harvesting and manufacturing wood products. For those who want to further their understanding and industry experience, this workshop will provide an opportunity to learn the differences in raw material consumption across forest product business segments and regions. Participants will gain understanding of the values associated with harvesting and manufacturing wood products in each region; instructors will introduce the related terminology and convey an understanding of which raw materials (and associated costs) are appropriate for use in various forest products industry sectors.

This information is a great fit for anyone new to the forest products business, USFS staff, other local and State government agency staff, accountants, salespeople, legal counsel, and human resources staff at existing forest products manufacturing companies who seek a basic understanding of wood-based raw materials and their importance in forest products manufacturing.
